The authorities of the Yaojia Detention Center have persecuted Falun Gong practitioners since July 1999. They use various methods to torture practitioners who refuse to renounce their belief in Falun Gong, including beating, shocking with electric batons, sleep deprivation, force-feeding, etc. They tie up practitioners' four limbs, then pour a mixture of highly concentrated salt water and corn starch into the stomach, without stopping even when the stomach becomes full, continuing until food overflows through the nose and mouth, causing tremendous pain.

1. **Ms. Sun Yan 孙燕**, 37, was a kindergarten teacher at the Dalian Oil Chemistry Corporation. In April 2001, Ms. Sun was detained in the Yaojia Detention Center for practicing Falun Gong. She held a hunger strike and was handcuffed and tortured. After she was persecuted to the verge of death, her family was allowed to bail her out.

In December 2004, she was arrested again and detained in the Yaojia Detention Center. Sha Ying, Meng Jun, and others tortured her. Ms. Sun went on hunger strike to protest her arrest, and she has now become extremely weak. She now experiences periodic unconsciousness in the Yaojia Detention Center. However, her family is not allowed to visit her.

2. **Ms. Ma Xueqing 马雪青**, female, was arrested and detained in the Yaojia Detention Center on July 28, 2005. Due to the torture, she has suffered a heart problem, and her family is not allowed to visit her. She is still detained in the detention center.
3. **Mr. Sun Liwen 孙立文**, male, 32, lived in Heishijiao. In 2000, because he went to Beijing to appeal to the government to stop the persecution of Falun Gong, he was detained in the Dalian Detention Center, and later sent to the Dalian Labor Camp and detained in the Masanjia Labor Camp for one year. Then he was detained in a labor camp in Jilin Province for three years, and his term was extended by several months.

On June 30, 2005, he was arrested again and detained in the Yaojia Detention Center. His family is not allowed to visit him.
